Model ROCKET VAC XP HEPA is similar to approved Model ROCKET VAC XP except for use of HEPA filter in lieu of VFD filter, and 4L capacity in lieu of 5L.

Model D'LITE is similar to approved Model ROCKET VAC XP except for model designation and brand name of 'RUGGED'.

Addition of back pack vacuum cleaner Model ROCKET VAC, branded 'ROBOTIC', rated 220-240Vac / 50Hz / 1200W, incorporating a series motor, housed in thermoplastic enclosure, Class II.
